3. COMPETENCES

7. DISTRIBUTION OF SCORES AND CRITERIA OF EVALUATION

The discipline consists of two content modules and its study involve the implementation of two ISRW in each semester. In this case, the final score on the 100-point scale consists of the total number of points for:

1. current evaluation of relevant topics (maximum 40 points);

2. module control work – MCW (maximum 60 points).

Evaluation criteria: passing each of the topics of content module 1, which are submitted to seminars, the student can obtain a score (Table 4). The total amount of scores that a student receives from Module 1 (seminars and ISRW) - 40. Thus, the total score of the current control is 40.

After mastering the content module, it is mandatory to write a module control work. The tasks of MCW indicate how many points can be set for each task, if it is performed correctly. Students receive a certain number of scores for the MCW. The total score for MCW is 60.

The final control is in the form of an exam, the maximum score is 60 points. The student must pass the exam if he scored less than 75 points during the semester, or if he does not agree with the points he scored. In this case, the points for MCW are canceled, the points for the current control remain.

The exam is in the form of a final test in Office-365 (Forms).

The total amount of points for the course is 100. The grade for mastering the course is set according to the assessment scale (Table 5).
