"Pandemic accord" to create a digital surveillance society

The problem with the Pandemic accord is that it is an attempt to ethnically cleanse Japan by having only Japan ratify it, rather than the West, which is aware of the dangers of mRNA vaccines, and Japan is the only target. The Japanese government is now forcing its citizens to receive the eighth vaccination even in January 2024. Furthermore, they plan to begin routine vaccination in 2024. This is extremely unusual. Even though there are many side effects of vaccines and many people are dying, the Japanese government is trying to implement compulsory vaccinations called routine vaccinations. The more you get vaccinated, the more likely you are to get infected with CORONA Virus. There is a possibility that only Japan will drag out the pandemic until the end. It is necessary to stop the activities of the WHO and IHR in Japanese territory.

"Most doctors in Japan cannot understand that genetically modified vaccines are fundamentally wrong. By making a pathogen's protein in your body, all the cells that make that protein become targets for the immune antigen and are killed by the immune system. In short, humans die from autoimmune diseases." Such a thing is a "genetically recombinant vaccine." We need to clearly inform politicians of this fact. Even for politicians, their families are victims of vaccines. In particular, when it becomes a replicon, there is a high possibility that it will spread through shading. Therefore, even if a politician thinks that it is safe because he does not take the vaccine, his whole family will become infected at once due to shedding.

To begin with, both the Pandemic Accord and the International Health Regulations are population reduction plans that are far removed from medicine. Pandemic accord requires "two-thirds approval at the WHO General Assembly." However, most countries around the world have no intention of ratifying this treaty. However, the International Health Regulations stipulate that this treaty can be passed with "the approval of a majority of the countries attending the WHO General Assembly." Therefore, countries that do not attend the WHO General Assembly are considered to have endorsed the Convention. For example, if 50 countries preside at the WHO General Assembly and 26 countries agree, all member countries will be bound by this treaty. Those who control the WHO and aim to reduce the population are trying to get the Pandemic Accord approved by the International Health Regulations. The way these proceedings proceed is a deliberate attempt to deceive people.

Their schedule is to have it passed by May 2025. Both Klaus Schwab and Tedros announced their plans at Davos. They prophesy that "Disease X" will occur. In other words, we are declaring that we will cause "Disease X." They say "May 2024 is the last chance." The revised text of the WHO International Health Regulations (2005) is as follows:

"The text of the proposed amendments shall be communicated to all Parties by the Director-General at least four months (27 January 2024) before the Health Assembly at which they are proposed for consideration. [IHR Article 55 Amendment, Article 2]"

This means that the text is in its final version and will be presented by the WHO to the Parties four months before the General Assembly. The article states, "Member states are requested to hold discussions during this four-month period." However, a representative from Japan's Ministry of Health, Labor and Welfare replied, "As of now, each country has already submitted its amendment bill." This means that the Japanese government has already sent a revised proposal to the WHO, so it satisfies the WHO's provisions.

However, this interpretation of the Japanese government is completely wrong. In other words, the Japanese government says that the WHO Health Regulations are not the final version and are currently under discussion. This announcement by the Japanese government is a fraud. Parties are not allowed to express their opinions to the WHO Director-General. The final regulations will be presented by the WHO to the Parties. The final deadline is January 27, 2024. However, this WHO notification to States Parties violates Article 55 of the IHR. The WHO has ordered that the treaty issued in May be ratified in May without giving any time to think about it. In order to ratify the treaty without the people knowing this fact, Japan's Ministry of Foreign Affairs has rewritten its website and is disseminating false information to the people.

Many countries will leave the WHO, but only Japan will remain. This is because Japanese people worship the United Nations and WHO like religion. Specifically, the Pandemic Accord will be approved by a majority vote on the second day of the WHO General Assembly in May 2024.

Additionally, in May 2022, HIR Article 59 was revised. The amendments were to shorten the period for refusal and reservation from 18 months to 10 months, and shorten the period for issuance from 24 months to 12 months. The final deadline for this agreement was the end of November 2023, but it was concluded without any discussion. Article 59 of the IHR, like Article 55 of the IHR, applies to all amendment procedures. Originally, the WHO Director-General must notify the contracting parties at least four months before the WHO General Assembly. However, there was no such notification from Secretary General Tedros. In response, several countries, including the Philippines, New Zealand, and the Netherlands, argued that "this revision is invalid." Lawmakers from the Philippines and the Netherlands have written to Tedros accusing him of not honoring the four-month deadline. Given this fact, it is necessary to fight against the WHO in cooperation with countries that can properly criticize it. The WHO is ignoring the rule that states parties have four months to consider the contents of the treaty.

The proposal for IHR Article 59, which was decided in 2022, was decided not at the WHO General Assembly, but on the day before the General Assembly. In other words, the committee's proposal was decided at Committee A the day before the general meeting. Moreover, the chairman of this committee is Japanese. The United States and Japan cosponsored this resolution. They held a closed-door meeting just before the committee meeting to finalize their proposal. They have continued to violate the rules without public knowledge. The revision of HIR Article 59 in May 2022 and the conclusion of the Pandemic accord are all connected together. Under this treaty, people all over the world will be forced to take highly poisonous vaccines and die in 2024.

Over the past decade, many IT companies have been working behind the scenes to create a digital surveillance society. The final destination of the digital surveillance society is the Pandemic Treaty. Contact tracing apps were used around the world to prevent infectious diseases. A "5G antenna" collects information from an individual's smartphone. 5G is a communications project created by the Chinese spy company HUAWEI.

Therefore, the Chinese government can see the information collected by this 5G. In this way, infectious diseases and IT are connected, and both originated in China. Additionally, Japan is the host country for the International Health Regulations (IHR). According to paragraph 44 of this revised regulation, "developed countries must provide developing countries with surveillance system technology." However, manufacturing surveillance systems requires semiconductors for surveillance systems, but Japan is unable to manufacture them due to a lack of semiconductors. However, Taiwan Semiconductor Manufacturing Company Limited (TSMC; also called Taiwan Semiconductor), a Taiwanese company based in mainland China and run by the Chinese Communist Party, is making the chips needed for the surveillance system in Japan's Kumamoto Prefecture. other words, the Pandemic Accord is a business contract that allows Japan to deliver surveillance systems around the world in accordance with Section 44 of the IHR.

So, what is the intention behind the formation of a surveillance society? Those who rule the world want to constantly monitor the people to ensure that they do not rebel against the ruling class. Of course, they lied about measuring the transmission of the virus to keep the public from knowing their intentions, allowing the government to digitally monitor the public. What politicians fear most is that forces hostile to them will secretly gather and their power will grow larger and larger. It is necessary to monitor this force, divide the people, and understand the content of the people's conversations. And if this force shows signs of growing, it will be crushed. However, since the Pandemic Convention is a treaty, it is placed above the Constitution. Even if human rights are guaranteed by the constitution, they are ignored by treaties that are higher than the constitution. For this reason, the formation of a surveillance society takes the form of a treaty. In fact, the Liberal Democratic Party is plotting to abolish human rights by amending the Constitution.

Embalmers in four countries, including the United States, have reportedly found strange fibrous blood clots in the bodies of people who received the COVID-19 vaccine. A recent study surveyed 269 embalmers from four countries on three continents. The survey was also conducted in the second half of 2022. At that time, it was reported that 66% of contractors found abnormal blood clots in corpses. A thrombus is a blood clot that blocks an artery. A year ago, it was a normal blood clot, but now it has turned into a fibrous, string-like blood clot.

According to funeral director John O. Loney, "I discovered the blood clots when they were pulled out of the corpse, and the longest one was about 3 feet long.." One thrombus was 90 cm long and string-like. "I've been in this profession for 12 years and handle 150 bodies a year, but I've never seen anything like this before. But it's not uncommon these days. These string-like blood clots have only been found in bodies that have been vaccinated with the COVID-19 vaccine. Now we know the answer." Over the past year, blood clots have grown as long as 90 cm, demonstrating the unusual toxicity of COVID-19 vaccines.

According to research by retired Air Force Maj. Thomas Haviland, "embalmers are seeing an increase in blood clots of all types in all age groups. These fibrous blood clots are caused by fibroin and It is made up of platelets, which are made up of two amyloid proteins. This amyloid protein has an misshapen or folded shape. Therefore, this protein is difficult to decompose in the body, making it easy to form blood clots. Therefore, thrombi form one after another and become longer and longer. Having such a huge blood clot in your body is frightening. Major Havilland sent the results of his investigation to the Centers for Disease Control and Prevention, the Food and Drug Administration, and the National Institutes of Health on January 9, 2024, but he has yet to receive a response. During these three periods, they do not respond because they know the answer.

The American Cancer Society (ACS) reported a sharp increase in new cancer cases late last year. In particular, cancer rates are rapidly increasing among young people between the ages of 15 and 45. The number of cancer cases among people who have received the COVID-19 vaccine has increased dramatically. Before 2020, young people were less likely to get cancer, but now 2 million young people get cancer every year. Despite this, the WHO is trying to force vaccinations in preparation for a new pandemic.
