ONLINE SOURCES OF INFORMATION ON UKRAINE'S FOREIGN TRADE WITH THE EUROPEAN UNION

To analyze, monitor, and forecast Ukraine's foreign economic activity, including trade in goods and services with the European Union, interested parties can use information from a number of websites. Let's consider the following online sources of information and the indicators they offer in more detail.




Fig. 1. Website of the State Statistics Service of Ukraine Source: [1].

The *State Statistics Service of Ukraine* on its website https://www.ukrstat.gov.ua/ in the "Statistical Information" section contains a subsection "Foreign Economic Activity" (Fig. 1).

Here you can find the following information:

- 1) geographical structure of foreign trade in goods with EU countries (2004–2024): exports, imports (thousands of US dollars; in % to the previous year) and balance (thousands of US dollars) by EU countries and together;
- 2) commodity structure of foreign trade with EU countries (2019–2024): exports, imports by goods (thousands of US dollars; in % to the previous year; in % to the total volume);
- 3) geographical structure of foreign trade in services with EU countries (2013–2021): exports, imports (thousands of US dollars; in % to the previous year) and balance (thousands of US dollars) by EU countries and together;
 - 4) structure of foreign trade in services (by type) with EU countries (2021-









2023): exports, imports (thousands of US dollars; in % to the previous year; in % to the total volume) and balance (thousands of US dollars) by services [1].




Fig. 2. Website of the State Customs Service of Ukraine *Source:* [2].

The *State Customs Service of Ukraine* on the official website https://customs.gov.ua/ in the section "Customs Statistics" contains a BI-system (from the English Business Intelligence – business analytics), where you can interactively familiarize yourself with the indicators of Ukraine's foreign trade (trade turnover, exports, imports, balance), by selecting the currency, year, quarter, month, partner country, country of origin of the goods, partner region, customs, customs post, transport, and also by specifying the goods (group, position, subposition, category, subcategory) [2]. This is shown in Fig. 2.

The site also provides information materials on the state of foreign trade in goods, including with the EU (million USD).




Fig. 3. Eurostat website

The statistical organization of the European Commission *Eurostat* has posted a database in the form of a navigation tree on its website https://ec.europa.eu/eurostat/data/database (Fig. 3), where you can find the following indicators:

- Extra-EU trade by partner (including Ukraine) for 2014–2023: trade balance, exports, imports (ECU/EURO), import share, export share (%);
- Extra-EU trade of food, drinks and tobacco (Standard international trade classification (SITC) 0+1) by partner;
 - Extra-EU trade of raw materials (SITC 2+4) by partner;
- Extra-EU trade of mineral fuels, lubricants and related materials (SITC 3) by partner;
 - Extra-EU trade of chemicals and related products (SITC 5) by partner;
 - Extra-EU trade of other manufactured goods (SITC 6+8) by partner;
 - Extra-EU trade of machinery and transport equipment (SITC 7) by partner [3].

The Office for the Development of Entrepreneurship and Exports has posted several interactive information panels on the website https://business.diia.gov.ua/analytics?showMode=ukraine: a dashboard on the export and import of Ukrainian goods; a dashboard on the export of Ukrainian organic products; a dashboard on the export of agricultural crops. More information about their content can be found in [4].

So, on the websites of the State Statistics Service of Ukraine, the State Customs Service of Ukraine, Eurostat and the Office for the Development of Entrepreneurship and Export, you can find statistical data on Ukraine's foreign trade with the EU.
